GARAGE 'WING WALL' REINFORCING PER IRC FIGURE R602.10.4.3





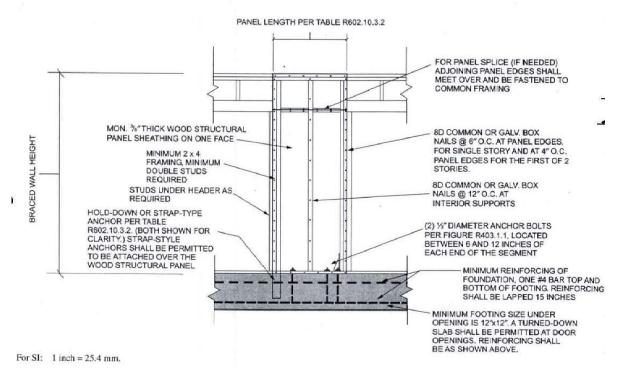


FIGURE R602 10.3.2 ALTERNATE BRACED WALL PANEL

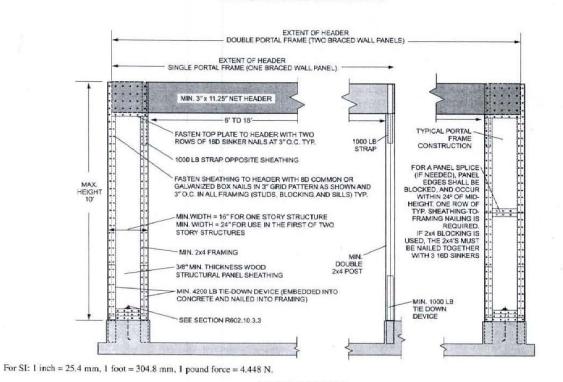








FIGURE R602.10.3.3 METHOD PFH: PORTAL FRAME WITH HOLD-DOWNS
